AB405-A1	Conduct workshop evaluating food access laws and policies	NDA, CFS		The Nevada Department of Agriculture (NDA) may have access to some of the information we need, but the foundation for this work comes from the Southern Nevada Food Council (SNFC). SNFC previously evaluated 34 food access policies dating from 2013 to 2025, including those from the most recent legislative session. A workshop now needs to be scheduled so the subcommittee can review and discuss these policies. The plan is to hold this workshop during the April committee meeting, and it is expected to take 40 minutes to 1 hour. Dr. Malik will send the 34 policies to the subcommittee before the April meeting, so members have time to review them in advance. This workshop is required to evaluate existing food access laws and identify gaps, strengths, and opportunities. Preparing for the April workshop means all subcommittee members should review the 34 policies ahead of time. AB405-B1	Utilize Healthy Food Access Map to identify areas of high food insecurity			Southern Nevada already has a completed food access map and a vacant land inventory, based on work done by the Southern Nevada Food Council. That information is available and can be used immediately. Northern Nevada, however, is still developing its version. The Northern Nevada Food Council (NNFC) is working on mapping food access and food pantry locations, but it is not yet finished. Because of that, the subcommittee needs to do additional research to understand what data exists and what gaps remain. The key question is: Who currently has a complete food access map for Northern Nevada? Right now, Southern Nevada has one; Northern Nevada does not.							
AB405-B2	Overlay vacant land inventory (Southern Nevada) with food insecurity data			The RTC of Southern Nevada has already completed a vacant land inventory identifying roughly 40,000 acres of available land in Southern Nevada. This work was published in 2024 or 2025, and it can be used as an existing resource for the subcommittee's analysis. It is not yet clear whether Northern Nevada has a comparable inventory. Southern Nevada also has a food access map, but it is still unknown whether Northern Nevada has a similar map. The Northern Nevada Food Council (NNFC) is working on mapping food pantry locations, but their broader food access map is not yet complete. Because of this, the subcommittee needs to research what Northern Nevada currently has and what gaps remain. The May meeting is expected to focus on reviewing both the food access map and the vacant land inventory. These are two separate mapping resources, and both are needed to understand statewide food access gaps and opportunities. A key question is whether the policy requires the subcommittee to recommend a statewide food access landscape assessment or simply evaluate what already exists. It is also unclear whether policymakers are aware that Southern Nevada already has these resources. To address this, the subcommittee should highlight all currently available resources in its report. To move forward, the group needs to: 1. Determine whether Northern Nevada has a food access map or any partial mapping. 2. Gather available Northern Nevada data. 3. Decide whether a statewide assessment is needed to fill gaps. 4. Conduct a partner-mapping activity at a future meeting to identify who is involved and how efforts connect across the state. During a future meeting, the subcommittee will hold a whiteboard-style collaborative activity. The goal is to visually map out a web of partners—showing how organizations connect, where efforts overlap, and where additional coordination may be needed. This exercise will be based on the partners that subcommittee members already know and work with. Once the subcommittee creates this initial partner map, it can be presented to the full Council. Council members can then add any additional partners or connections that were not captured, helping to build a more complete statewide picture. SB233-1		Identify and convene stakeholders to provide input on long-term cost pressures (e.g., warehousing, transportation, coordination, software)	NDA, Farm Bureau		NDA must be at the table before any meaningful progress can be made. NDA is the agency responsible for initiating the contracts for the Home Feeds Nevada program, while the food banks are primarily the receivers of the product. Because of this, the committee needs NDA's involvement to address key logistical issues such as storage capacity, transportation, and distribution flow. A request will be made for an NDA representative to formally sit on the subcommittee, so questions can be addressed directly during meetings rather than waiting weeks between updates. This participation is essential for statewide coordination and for understanding how the program will function in practice. In addition, the committee must research how other states fund and operate similar programs. More than 20 states have comparable models, and members will divide the list of states and bring their findings to the April meeting. This research will help the subcommittee understand funding structures, operational models, and potential best practices that could apply to Nevada. To do this, the committee needs to explore what other states are doing and speak with individuals in the State Treasurer's Office, who may know where additional funds could be identified, allocated, or repurposed. The goal is to take a holistic approach to funding and program design. More than 20 states already have comparable programs. The committee needs to understand: 1.) How those programs are structured. 2.) How they are funded. 3.)What models might apply to Nevada. A list of these states already exists, and Shane will share it with the Council. Once the list is distributed, each committee member will be assigned one or two states to research.
