Pursuant to NRS 439A.100, PCHC is the holder of a Letter of Approval subject to the provisions of NAC 439A.455 - 439A.505, inclusive. On or about September 12, 2025, NVHA issued a "Notice of Intent to Initiate Proceedings to Withdraw Letter of Approval" to PCHC based on criteria set forth in NAC 439A.505. This hearing will address the Director's proposed withdrawal of PCHC's Letter of Approval based on the holder's noncompliance with regulations including NAC 439A.465, NRS 493A.475, and NAC 439A.485.
