compensation of Members and Employees."

Staff Review

On November 3, 2025, a Medical Laboratory Advisory Committee (MLAC) meeting was held by teleconference. One of the action agenda items to consider was to designate an individual who meets the requirement of Nevada Revised Statutes 652.170(4)(b), which is to have one medical technologist as part of the composition of the MLAC. There is currently one such vacant MLAC member position.

There were 14 qualified people who completed and submitted informational documents to indicate an interest in becoming a member of the MLAC. A quorum of the MLAC members reviewed the submitted documents and voted for the applicant whom the members determined would be the best candidate to fill the one medical technologist vacancies.

With a unanimous vote from a quorum of the members, the one applicant chosen to fill the medical technologist vacancy is Nassreen Fontanilla Manliswe, MSHS-CLS, MLS (ASCPi CM).

In accordance with the Nevada Revised Statutes 652.1701(1), it is the responsibility of the State Board of Health to appoint the seven members of the MLAC. Statutorily, the members of the MLAC are allowed to serve two consecutive three-year terms. If approved by the Nevada Board of Health as an MLAC member, Nassreen Fontanilla Manliswe, MSHS-CLS, MLS (ASCPi CM) would be allowed to begin her first three-year term on the MLAC.
