Proposed Changes to Regulation: Nevada Administrative Code (NAC) 459 (LCB File No. R073-25)

Purpose and Instructions

This questionnaire is seeking feedback from affected businesses regarding the potential economic impact of proposed changes to NAC Chapter 459. These amendments relate to: (1) adoption by reference of federal regulations governing radioactive materials; (2) revision and repeal of state provisions that duplicate federal regulations; (3) updates to the definition of "physician" for purposes relating to the use of X-rays in the healing arts; (4) requirements governing of radiation content in certain materials; and (5) other matters properly relating to the regulation of radiation and radioactive materials in Nevada.

If the agency determines that the proposed regulations are likely to impose a direct and significant economic burden on a small business; or directly restrict the formation, operation or expansion of a small business; then the agency may take one or more of the following actions:

2. Consider methods to reduce the impact of the proposed regulation, and
3. Prepare a small business impact statement and make copies of the statement available to the public at the workshop conducted and the public hearing held pursuant to NRS 233B.061.
