#### 1. Roll call and confirmation of quorum.

T. Emmerich-Choi read the roll call and stated that there was a quorum present.

#### 2. Approval of minutes:

S. Vanbeuge asked if there were any additions or corrections to the minutes from the January 18, 2022 meeting. No recommendations were made.

**First Motion:** moves to pass the approval of minutes

**Second Motion:** seconds **Motion:** Passes Unanimously

3. Recommendation to the Administrator for the Division of Public and Behavioral Health regarding a J-1 Physician Visa Waiver Letter of Support for Dr. Angeline Prabhu.

Skye Moreland presented summary handout of the completed application. Dr. Qureshi states that he will recusing himself from commenting and voting due to there being a conflict of interest as they share the same specialty. Dr. VanBeuge asks if there are any questions about the packet, Tarryn Emmerich-Choi states that if there are any

questions, Brett Strand, Dr. Prabhu's attorney, is on the line and available. Dr. VanBeuge asks if the practice is new, B. Strand confirms that it is an expansion of an existing practice, Valley Oaks has acquired a number of clinics in the Las Vegas area and other locations throughout the United States. Dr. VanBeuge asks if this office is under new management or are they utilizing people that the practice has previously. B. Strand states that he can call his client to confirm, but to his knowledge they have acquired an existing clinic, have taken ownership of it and are expanding operations. Dr. VanBeuge asks if a Dr. Shah will be running the practice or will be in charge in anyway. Brett Strand states that no, based on his knowledge this is an organization that is acquiring primary care practices across the United States and he has no knowledge of a Dr. Shah being involved. Dr. VanBeuge asks to confirm that there is no direct or indirect involvement with a Dr. Dhaval Shah. B. Stand states that he has never heard that name before, and that he can confirm with the practice management and let the PCO know. Dr. VanBeuge states that it would be very helpful to have that confirmation. B. Strand states he will get the information back to the PCO by close of business. Gerald Ackerman asks if this question will prevent the application from moving forward. Dr. VanBeuge states that she would prefer to hold onto the application until they received this information for the best interest of the applicant. B. Strand states that he could call to get the information now instead of having to reschedule the meeting. T Emmerich-Choi states that the council is able to vote to approve an application contingent on receiving the required information. Pierron Tackes states that the council can vote to approve with the contingency that Dr. Shah is not involved, or the council can choose to take a quick recess to allow Brett Strand to make the phone call to get the required information. G. Ackerman states that he is not sure what the hesitation over Dr. Shah is, but based on Dr. VanBeuge's hesitation he is happy to wait for the information. Nancy Bowen states that she feels the same way, and based on Dr. VanBeuge's recommendation she would hold off on approving the application until they receive the information. Julie Clyde concurs with G. Ackerman and N. Bowen. T. Emmerich-Choi asks Pierron if it would be appropriate for Dr. VanBeuge to clarify her concerns, or would it be best to take a recess for Brett Strand to make his call. Pierron states that per the duties in statue for this committee part of that responsibility is determining whether the application is compliant with the statute, and one of the requirements is whether or not the waiver would be in the interest of the public. P. Tackes continues to say that in her understanding of the discussion is that there was a concern with whether a placement with a doctor that the program has previously worked with would be in the interest of the public. Dr. VanBeuge thanks Pierron and confirms that she would like clarity on the involvement of the doctor Shah before approving the application. B. Strand states that he is almost completely sure that the doctor is not involved, but would like to confirm before stating on record, he continues to state that the committee has approved applications for this employer before. Dr. VanBeuge states that the council has a few different options, approve the application with continencies, table the application for a meeting on a future date, or take a recess and allow B. Strand to make his phone call. B. Strand requests that they take a approve contingent on receiving the application due to Dr. Prabhu having a timing issue with the end of her current placement and starting her new employment. G. Ackerman states that the state is in need of Infectious Disease specialists and states that they would not want to lose the opportunity to gain a specialist, therefore he would be more in favor for approving the application pending the receipt of the information requested. J. Clyde and N. Bowen agree with Gerald Ackerman, that they would approve the application contingent on the receipt of the information. Dr. VanBeuge agrees, stating that there is a need for Infectious Disease Specialists.

**First Motion:** N.Bowen makes a motion to approve contingent on receipt of the information regarding Dr. Shah's involvement

Second Motion: G. Ackerman seconds

**Member Comment:** G. Ackerman pauses the motion to ask if the council would not approve the application if Dr. Shah is involved, even if he is not directly managing the J1 applicant. Dr. VanBeuge asks if they should amend the

motion to stipulate that if Dr. Shah is involved then the application would not be approved. G. Ackerman asks if they need to stipulate what kind of involvement Dr. Shah has with the applicant in the motion, to decide whether they approve the application, as Dr. Shah could be involved with the group, but not be in direct contact with the applicant. Dr. VanBeuge asks if he would like to amend the motion. G. Ackerman states that there needs to be more caution in the wording of the motion. S. VanBeuge asks Pierron for legal counsel, should the council redo the motion or is there a better way they could go about this. Pierron states that there is not a clear path in the event that Dr. Shah is involved, and believes that G. Ackerman is suggesting that the committee might not want to decline the application if the doctor is involved, but instead might want to look at the application further. Pierron continues to suggest that if this can be cleared up with a phone call by B. Strand, that a short recess might be best so there won't be a question outstanding that would require a further meeting. B. Strand states that he would be more than happy to make a call. Dr. VanBeuge asks the council if they have time for a short recess, the council all states yes.

#### The Council votes to take a 10-minute recess at 11:24

The Meeting adjourns at 11:35, Tarryn Emmerich-Choi reads roll call and confirms that there is quorum after the recess.

Dr. VanBeuge asks B. Strand if he has any further information for the committee after the recess. B. Strand states that he was able to speak with the owner and CEO of Valley Oaks Medical Group, he was able to confirm that the organization has no connection to Dr. Dhaval Shah. The owner purchased the practice from Dr. Shah when Dr. Shah was no longer able to continue in the practice. Dr. Shah is completely disconnected from the practice at this time, no ownership or employment at all. Dr. VanBeuge thanks Dr. Strand for the clarification and states that it would be best to withdraw the first motion and start again. Pierron confirms.

Dr. VanBeuge thanks E. Lynch for her introduction, states that the council cannot comment due to this being a public comment section, and states that perhaps E. Lynch could be in a future meetings agenda to further discuss how the new movement and the PCAC can work together in the future.

### Nevada Primary Care Office - Conrad State 30 J-1 Visa Waiver Program EMPLOYER/SPONSOR Affidavit and Agreement Sponsorship and Eligibility Requirements

- A. **Medical Practice Criteria and Policies**: To be eligible to employ a J-1 Visa Waiver physician, a medical practice must comply with these requirements.
  - 1. Located in a federally designated Health Professional Shortage Area (HPSA), a federally designated Medically Underserved Area or Population (MUA/P), or a "flex slot" documenting service to underserved populations, as verified by the state. Determine if locations are designated at the following link: https://data.hrsa.gov/tools/shortage-area
  - 2. The site must have been operating at least six months before requesting a physician under the J-1 visa waiver program.
  - 3. Submit all components of the application available online.
  - 4. For new sponsors, Agree to review the Rights and Responsibilities presentation upon the start of employment (presentation located online at <u>Conrad 30 J-1 Visa Waiver Instruction, Information & Forms</u>).
  - 5. Report additional employment of the physician. Any additional or outside employment in which the J-1 Visa Waiver physician engages must be stipulated in the original contract or added to a new contract which must then be resigned by all parties and resubmitted to the Primary Care Office (PCO) for recommendation for USCIS approval, if applicable. Any employment expectations regarding hours worked vs. hospital rounds and/or on-call requirements must be specified in the contract; the same applies to travel time.
  - 6. The practice site must accept all patients regardless of ability to pay, accept Medicaid and Medicare on assignment, and use a sliding-fee scale based on federal poverty guidelines to discount services to low-income uninsured persons. The medical practice must provide notice to the public that such a policy is in effect and apply these access standards to the entire medical practice, not simply to those patients treated by the J-1 Visa Waiver physician. These requirements should be in place for at least three months immediately preceding the request for waiver. Federal poverty guidelines are available at the following link: <a href="https://aspe.hhs.gov/poverty-guidelines">https://aspe.hhs.gov/poverty-guidelines</a>.
  - 7. Agree that the physician will use an individual National Provider Identifier (NPI) from the Centers for Medicare and Medicaid Services on all Medicaid health care claims.
  - 8. Agree to be monitored by the DPBH, PCO, on a periodic basis for compliance with this agreement and provide required documentation to the PCO on the required forms.
  - 9. Agree to report practices within the practice site setting that do not meet the standards of care as established by the Nevada State Board of Medical Examiners. <a href="http://www.medboard.nv.gov/">http://www.medboard.nv.gov/</a>.
    - NRS 41A.009 "Medical malpractice" defined. "Medical malpractice" means the failure of a physician, hospital or employee of a hospital, in rendering services, to use the reasonable care, skill or knowledge ordinarily used under similar circumstances.

- 10. Report semi-annually each April and October, via the Compliance Confirmation Verification form on the status of the physician services for the previous six months and where those services were provided (located online at <u>Conrad 30 J-1 Visa Waiver Instruction, Information & Forms</u>).
- 11. Agree to immediately report all changes to the work schedule, changes which will be in effect longer than three weeks, to the PCO on the Change of Status form (located online at Conrad 30 J-1 Visa Waiver Instruction, Information & Forms). These changes include, but are not limited to, a temporary assignment to another practice site, a decrease in hours at the practice site, an increase of call-time requirement, an increase in hospital-rounds time, and an increase in emergency room call. The most recent form on file will be used by the DPBH to assess whether the physician and employer are compliant with these policies and state law.
- 12. Notify the PCO, in writing, at least thirty days prior to a transfer from the approved facility to another facility within the medical practice. For a transfer outside the medical practice, the PCO must be notified, in writing, at the earliest opportunity. The DPBH reserves the right to approve or disapprove all transfers.
- 13. Notify the PCO, in writing, within thirty days of disciplinary action and/or termination. In the event of any emergency termination due to extreme circumstances affecting the health or safety of clients or other individuals, the DPBH must be notified no later than twenty-four hours after the emergency termination.
- 14. Understand that the PCO does not have the authority to mediate between employer and employees participating in the J-1 Visa Waiver program, or to enforce labor standards. Further, the PCO assumes no responsibility for negotiations or content of employment contracts or for termination of the contracts. If the PCO becomes aware of such issues, it will recommend seeking advice from an attorney or contacting the appropriate agency (i.e., Medicaid Fraud and Abuse, Department of Labor, United States Citizenship and Immigration Services, Medical Board of Examiners). The PCO will, however, investigate allegations of wrongdoing and issue a written determination of findings.

#### **Special Circumstances**

- 15. Employers in a non-designated site (flex slots) must provide evidence, when requested by the PCO, that patients reside in one or more geographic areas designated as HPSA and/or MUA/P.
- 16. Employers of physicians who are granted a Specialist designation must be able to document compliance with the number of hours, locations and duties specified in the contract. For example, if the contract indicated that the Nephrologist was to work twenty hours as an Internal Medicine physician at an out-patient clinic, in addition to twenty hours as a Nephrologist at a specific hospital, the PCO may require documentation to support compliance.

#### **B.** Consequences of Default:

17. An employer is in default if, at any time, he or she does not meet the conditions listed in section A. The DPBH, PCO will monitor the physician and the medical practice. An employer found in violation of Nevada Revised Statutes 439A.130 to 439A.185 or Nevada Administrative Code (NAC) 439A.700 to 439A.755 will incur the penalties specified under NAC 439A.750.

### Nevada Primary Care Office - Conrad State 30 J-1 Visa Waiver Program PHYSICIAN Affidavit and Agreement Sponsorship and Eligibility Requirements

- A. **Eligibility**: To be eligible for a letter of support by the Nevada Division of Public and Behavioral Health (DPBH) a physician must:
  - 1. Complete a residency or fellowship training program and intend to practice in Nevada for a period of three consecutive years.
  - 2. Submit all components of the application available online.
  - 3. Acknowledge review and understanding of all terms included in the contractual agreement with the employer.
  - 4. Agree to notify the DPBH of the start date with the contracted employer, using the Verification of Status form (located online at <u>Conrad 30 J-1 Visa Waiver Information, Instructions & Forms</u>)
  - 5. Agree to review the Rights and Responsibilities presentation upon start of employment (presentation located online at <u>Conrad 30 J-1 Visa Waiver Information</u>, <u>Instructions & Forms</u>).
  - 6. Agree to report additional employment. Any additional or outside employment in which the J-1 Visa Waiver physician engages must be stipulated in the original contract or added to a new contract which must then be resigned by all parties and resubmitted to the Primary Care Office (PCO) for recommendation and for USCIS approval, if applicable. Any employment expectations regarding hours worked vs. hospital rounds and/or on-call requirements must be specified in the contract; the same applies to travel time.
  - 7. Agree to limit absence from the practice site to a maximum of 180 consecutive days. If the physician is absent from medical practice more than 180 consecutive days, the physician must submit a Verification of Status Form to the DPBH, PCO. Exceptions may be approved under special circumstances, as determined by the DPBH PCO in advance of such absence.
  - 8. Agree to treat all clients regardless of ability to pay, accept Medicaid and Medicare patients on assignment, and use a sliding fee scale for low-income, uninsured individuals. The practice site must provide notice to the public, as evidenced by a sign in the waiting area regarding this policy.
  - 9. Agree to obtain, within sixty days of start date, an individual National Provider Identifier (NPI) from the Centers for Medicare and Medicaid Services, which will be used on all health care claims.
  - 10. Agree to be monitored by the DPBH, PCO, on a periodic basis for compliance with this agreement and provide documentation to the PCO on the required forms.
  - 11. Agree to report practices within the practice site setting that do not meet the standards of care as established by the Nevada State Board of Medical Examiners. http://www.medboard.nv.gov/.

NRS 41A.009 "Medical malpractice" defined. "Medical malpractice" means the failure of a physician, hospital or employee of a hospital, in rendering services, to use the reasonable care, skill or knowledge ordinarily used under similar circumstances.

- 12. Report semi-annually, via the Compliance Confirmation Verification form (located online at <u>Conrad 30</u> <u>J-1 Visa Waiver Information, Instructions & Forms</u>) on the status of the physician services for the previous six months and where those services were provided.
- 13. Agree to immediately report all changes to the work schedule, which will be in effect longer than three weeks, to the PCO on the Change of Status form (located online at Conrad 30 J-1 Visa Waiver Information, Instructions & Forms). These changes include, but are not limited to, a temporary assignment to another practice site, a decrease in hours at the practice site, an increase of call-time requirement, an increase in hospital-rounds time, and an increase in emergency room call. The most recent form on file will be used by the DPBH to assess whether the physician and employer are compliant with these policies and state law.
- 14. Notify the DPBH, PCO, in writing, thirty days prior to transfer, in the event of physician transfer from the approved facility to another facility within the medical practice or with another provider. The DPBH reserves the right to approve or disapprove the transfer.
- 15. Notify the DPBH, PCO, in writing, within thirty days of disciplinary action and/or termination. In the event of any emergency termination due to extreme circumstances affecting the health or safety of clients or other individuals, the DPBH must be notified, no later than twenty-four hours after the emergency termination.
- 16. Acknowledge review of all contractual obligations, <u>including expectations for working hours, hospital rounds, and on-call requirements</u>. The DPBH has limited authority under <u>NRS 439A.180</u> to ensure program requirements are met and cannot mediate labor disputes; therefore, <u>the physician must review all contracts carefully before signing</u>. Labor disputes or medical safety issues will be referred to the federal Department of Labor or to the Nevada State Board of Medical Examiners.

#### **Special Circumstances**

- 17. Physicians who work in a non-designated site (flex slots) must provide evidence, when requested by the PCO, that patients reside in one or more geographic areas that are designated as HPSA and/or MUA/P.
- 18. Physicians who are granted a Specialist designation must be able to document compliance with the number of hours, locations and duties specified in the contract. For example, if the contract indicated that a Nephrologist was to work twenty hours as an Internal Medicine physician at an out-patient practice site, in addition to twenty hours as a Nephrologist at a specific hospital, the PCO may require documentation to support compliance.

#### **B.** Consequences of Default:



Please accept this letter as an indication of our support for Dr. Jeroen Balledux's continued privileges at Sunrise Hospital and Medical Center via the Conrad 30 J-1 Physician Waiver Program. As you are aware, Dr. Jeroen Balledux is a plastic surgeon and a member of the medical staff at Sunrise Hospital. Through his employment with BRCA he provides burn and wound services to patients of our facility.

Sunrise Hospital initiated a burn program on October 1, 2019. In this program Sunrise Hospital accepts all patients regardless of their ability to pay, including Medicaid and Medicare. Patients without insurance are evaluated against the uninsured and charity policy which we have provided to you. This policy eliminates patient liability greater than \$1,500 when the household income is less than 200% of the Federal Poverty Guideline. Balances for individuals above 200% of the Federal Poverty Guideline have their liability capped at a percentage of their annual household income. For example, an individual with income between 201% and 300% of the FPL would have their balance capped at 3% of annual household income.

The burn program is supported by 2 general surgeons and 1 plastic surgeon (Dr. Balledux). Dr. Balledux is a plastic surgeon. Our 2020 Physician Needs Assessment showed a total need for 25.2 plastics physicians in our service area. Sunrise currently has 8 plastics physicians with active staff privileges and 9 physicians with associate/affiliate privileges. Excluding the 8 plastics physicians with active privileges, there is a potential need for 17 physicians. The burn program supports the needs of patients throughout a wide service area encompassing primarily Southern Nevada and Northern Arizona. Forty-seven percent of the patients seen by the clinic are Medicaid or uninsured.

Thank you for your support of Dr. Balledux and the burn program at Sunrise Hospital.

Sunrise Hospital is a level-2 trauma center providing critical trauma services for Las Vegas and its surrounding areas. In 2019 it partnered with the Burn and Reconstructive Centers of Nevada to create and operate the Burn and Reconstructive Center at Sunrise Hospital with the goal to provide the best available burn and wound care for adult and pediatric patients. The facility is being expanded to 15 beds for burn patients to account for the increased need. Unfortunately, the number of physicians has not

kept up with the rapid population growth in the area. Nevada currently ranks 48<sup>th</sup> overall for number of physicians per capita. In the area of employment, there is one surgeon for every 12,500 people which ranks the state 50<sup>th</sup> in number of surgeons per capita in the US.

The burn program at Sunrise Hospital is supported by 2 general surgeons and 1 plastic surgeon. According to the Hospital's 2020 Community Needs Assessment there is a physician deficit of 53.0 Full Time Equivalents and Plastic Surgery physician deficit of 15.7 FTEs. The supply for general surgeons was a net of 42 and plastic surgeons was a net of 7 FTEs for a population in the service area of 1,588,567. That is a significant deficit in physician need vis-à-vis the patient population that the facility serves more than 50% of the entire state population.

Dr. Balledux is an accomplished plastic surgeon with extensive experience in treating all burn related trauma, including chemical, radiation, electrical, friction, thermal and inhalation burns and reconstruction surgery. Given the shortage of specialist at the employment site, Dr. Balledux's services are of critical importance for Sunrise Hospital and the population it serves.

Thank you for your attention to this matter. I hope that based on the information provided, you will support us in our application and recommend that a waiver of the 2-year foreign residence requirement be granted.

This letter is to confirm that there is a critical need for the services of an Infectious Disease doctor to populations in several designated Health Professional Shortage Areas (HPSAs) in the Las Vegas area.

Currently, our clinic and servicing hospital is severely restricted in terms of the lack of Infectious Disease Physicians in our area. Often, for example, we are unable to accommodate patients with urgent needs and life-threatening infections because we do not have appointments open to schedule them for a physician visit.

There currently is a 9 to 12 week waiting time for patients seeking the type of Infectious Disease services that Dr Cedeno will provide. The next-nearest provider for Infectious Disease is approximately 15 miles away and only offer services once a week. We have several patients that travel over 100 miles to see our physicians, and our clinic has a walk-in policy for members of the community that need help with prep for HIV and STD's. Due to a lack of appropriate treatment in a nearer location; it is unknown but can be imagined that there are several patients who require treatment but cannot make that trip.

A recent study in the journal of Infectious Disease shows supply and demand projections over the next decade and found that, already, Infectious Disease has a shortfall of about 500 providers. The gap will for sure widen significantly due to the current pandemic of covid-19 and demand for Infectious Disease providers. These types of demographics have rendered the patient experience and patient care sub-optimal in the Las Vegas area. These issues would be greatly improved by the presence of Dr Cedeno in our clinic.



# Charity Discount Policy

Financial relief may be available to patients who have received non-elective care and do not qualify for state or federal assistance and are unable to establish partial payments or pay their balance. In most cases, this will apply to patients who fall between 0 - 200% of the <u>Federal Poverty Level</u>. Federal Poverty Levels based on total household income, with sufficient supporting documentation provided by the patient, will have a 100% Charity discount processed.

For patients with balances greater than \$1,500, and whose documented income is in-between 201 and 400 percent of the Federal Poverty Level, we have an expanded financial assistance policy that may reduce the amount you owe. To determine if non-elective services you received could be eligible for either full charity or partial charity, please contact your hospital for details on how you may see if you are eligible to receive assistance.

Some locations may have identified additional criteria for charity eligibility besides the Federal Poverty Levels as noted above (i.e., high medical costs, more lenient income levels, etc.). To verify your eligibility for assistance under this policy, we recommend you contact the hospital.
