

This letter is written by Pokroy Medical Group of Nevada Ltd. d/b/a Pediatrix Medical Group of Nevada ("Pediatrix Nevada") in support of the J-l waiver application on behalf of Dr. Devraj Jaysinh Chavda ("Dr Chavda"). As Pediatrix Nevada's Medical Director responsible for our Pediatric Neurology practice located in Las Vegas, I am asking that the Nevada Division of Public & Behavioral Health act as an interested government agency and recommend a J-l waiver for Dr. Chavda. Our medical practice provides pediatric neurology care to patients throughout Las Vegas. If the waiver is granted, Dr. Chavda would be employed under a 3-year contract by Pediatrix Nevada and would work in the pediatric neurology office located at 2020 E. Desert Inn, Las Vegas, NV 89169. This practice location is designated as a Health professional Shortage Areas ("HPSA"). Sunrise's HPSA Primary Care HPSA ID is 1328484648, with a HPSA Score of 16.

Pediatrix Nevada is a subsidiary of Pediatrix Medical Group, Inc. ("Pediatrix Medical Group"), which is in turn an operating division of Mednax, Services Inc. ("Mednax"), a national medical group that comprises the broad physician services of Pediatrix Medical Group. Pediatrix Medical Group was founded in 1979 as a neonatal physician group and has expanded to become the nation's largest provider of maternal-fetal-newborn care by remaining focused on one simple belief, taking great care of the patient. It has invested in the clinical, information and management systems necessary for physicians to improve patient outcomes through a series of evidence-based initiatives. As a strong national physician group, Pediatrix Medical Group is built on a foundation that successfully responds to the constant changes taking place in healthcare, and most specifically, the changing needs of patients.

Pediatrix has been providing pediatric subspecialty care throughout the United States for over forty years and specifically in Las Vegas for the past fifteen years. We provide medical care to Medicaid and uninsured patients. Hiring Dr. Chavda will give us the minimum "man-power" to continue to provide pediatric neurology services. As the Medical Director of the pediatric neurology practice and a pediatric neurologist with Pediatrix Nevada in the area, I am very much aware of the significant health needs of our city and state. We turn no patients away.

We currently have 3 Pediatric Neurologists in our practice and need 1 additional Pediatric Neurologist to be at full strength.

Sunrise Children's Hospital and Mountain View Hospital are part of the Sunrise Health System. Sunrise Children's is the largest and most comprehensive children's hospital in Nevada. They provide a full range of services designed especially for kids, from our dedicated pediatric emergency room and inpatient unit to our pediatric neurology program. Mountain View Hospital also provides neonatal and pediatric neurology services. Valley Health System encompasses four hospital facilities providing neonatology, pediatric critical care, pediatric, pediatric emergency, in addition to pediatric neurology services. University Medical Center is the only designated level II pediatric trauma center in Nevada and also provides neonatology, pediatric critical care, pediatric, pediatric emergency, in addition to pediatric neurology services.

Pediatrix provides medical care to Medicare, Medicaid and uninsured patients and use a sliding fee scale discount schedule. No patient gets turned down. Hiring Dr. Chavda will give us the core staff necessary to provide Pediatric neurology services in Las Vegas. If we continue to work at this pace without another Pediatric Neurologist, we run the risk that our service can no longer be provided at the high level of care needed because of professional fatigue and physical limitations of this pace.

I am very much aware of the significant health needs of our city and state, including a shortage of Pediatric Neurologists, and a lack of coverage of the on-call schedules or our practice. I can attest that we definitely need additional pediatric neurologists in the community. Dr. Chavda's expertise is greatly desired and needed. Las Vegas has been a difficult area to recruit Pediatric Neurologists for many reasons. We have been actively recruiting physicians for several years. Contacts were made through the Pediatrix corporate recruiter, at national meetings, by advertisements on various websites, including PedJobs.com, MDSearch.com, Society of Pediatric Neurologists and through emails and phone calls. We respectfully submit that permission to employ Dr. Chavda will support our efforts in providing comprehensive medical care to Las Vegas' underserved population and would also enhance our partnerships with the local community in the provision of pediatric neurology services.

In March 2015, the economic modeling and forecasting firm IHS Inc. released a new study, The Complexities of Physician Supply and Demand: Projections from 2013 to 2025, at the request of the Association of American Medical Colleges ("AAMC"). The report found that, although physician supply is projected to increase modestly between 2013 and 2025, demand will grow more steeply. It also found that, by 2025, demand for physicians will exceed supply by a range of 46,000 to 90,000. The report concluded that "Addressing the shortage will require a multi-pronged approach, including innovation in delivery; greater use of technology; improved, efficient use of all health professionals on the care team; and an increase in federal support for residency training. The study's results confirm that no single solution will be sufficient on its own to resolve physician shortages."

In a June 2018 Report entitle "Physician Workforce in Nevada 2018" published by the Nevada Health Workforce Research Center provides current data on the supply of physicians,

nurses, and other health care workers in Nevada. The report acknowledges that while the population of Nevada has grown since 2005, its physician-to-patient ratio has remained flat despite efforts to attract more doctors to Nevada. Nevada is mired at 47th nationwide for active physicians and 48th for active primary care doctors per 100,000 residents. The Report states that "A common feature of licensure trends over the past decade has been substantial growth in the number of licensees for most health professions, yet modest, if little, growth in the number of licensed health professionals per capita. For example, from 2006 to 2016, the number of licensed allopathic physicians (MDs) grew, from 4,062 to 5,092, or by 1,030 (25.4%). However, the number of licensed MDs per 100,000 only increased by 19.1 percent during the same period due to steady population growth. This "treading water" trend typifies medicine and most of the licensure data presented in this section and helps explain why Nevada's poor health workforce rankings among U.S. states do not change appreciably from year to year, despite the fact that the number of licensees in most fields has grown over the past ten years."

Employing Dr. Chavda will support our efforts in providing comprehensive medical care to Las Vegas's underserved population and would also enhance our partnerships with the local community. The population of Las Vegas is about two million and there is a dire need for local specialist care physicians with special training, experience, and skills in evaluating children who may be affected by any type of neurological disability.

As a Pediatric Neurologist, Dr. Chavda would evaluate patients and formulate diagnosis and treatment plans. 





Dr. Ahmadjee has completed his fellowship in interventional cardiology in 2021, he has completed prior fellowship in cardiovascular medicine in 2019 and his residency in internal medicine was complete in 2016. He is currently residing in Saudi Arabia and we would like to bring him back to the US to work with our organization to complete his J-1 visa waiver requirements. Interventional cardiology is a branch of cardiology that deals specifically with the catheter-based treatment of structural heart diseases.

Saint Mary's Medical Group is a fully-integrated Medical Group which offers a robust line of services including primary care, urgent care, and specialty care including the Center for Neurovascular and Stroke Care, the Center for Cardiovascular Care. Designed to unite a team of board-certified physicians, specialists and nurse practitioners, the Medical Group is focused on preventive care. Saint Mary's Medical Group includes physicians who specialize in family practice, osteopathic physicians, physician assistants and nurse practitioners. As a long-standing community partner, Saint Mary's Medical Group is dedicated to ensuring the health and wellness of northern Nevada remains strong. Saint Mary's Pulmonary and Critical Care specializes in treating a wide variety

A physician shortage continues to be a problem in Nevada and is hindering patient care access hardest in rural regions, according to a recent report focusing on health care workforce trends. According to the latest data published in the report, "Physician Workforce in Nevada: A Chartbook - January 2020," demand for physicians in Nevada continues to exceed the current supply. While the number of licensed physicians in the state has increased over a decade, Nevada ranks 45th for active physicians per 100,000 population, 48th for primary care physicians per 100,000 population.

In addition to gaps in care for certain specialties, the report data points to several obstacles to developing a stronger physician workforce in Nevada, "A key obstacle is underdeveloped fellowship and subspecialty training opportunities for physicians completing residencies in Nevada. If physicians leave the state for additional training, they don't necessarily come back," said the report's lead author Tabor Griswold, Ph.D., health services research analyst for UNR Med's Office of Statewide Initiatives. "Another obstacle is that we are surrounded by other western states with equally severe shortages that create strong regional competition for physicians."


According to The Washington Post, COVID-19 and cardiovascular diseases are inextricably linked, "A large-scale scientific study found that coronavirus patients were at "substantial" risk of heart disease one year after their illness, increasing the odds of clots, arrhythmias, heart failure and related conditions. The risk of heart diseases grew progressively depending on the severity of the covid illness, according to researchers who analyzed health records from more than 153,000 U.S. veterans who had covid. The results were published in Nature Medicine this week."

In another article published by NBC News (citing Nature Medicine) states, "Indeed, it appears the coronavirus can leave patients at risk for heart problems for at least one year following infection, according to one of the largest analyses of post-Covid health effects to date. The study, published last week in Nature Medicine, found that the illness increased the possibility of heart rhythm irregularities, as well as potentially deadly blood clots in the legs and lungs, in the year after an acute infection. Covid also increased the risk for heart failure by 72 percent, heart attack by 63 percent and stroke by 52 percent — even among those, like Wilson, whose original illnesses were mild." (Source: https://www.nbcnews.com/health/health-news/covid-risks-heart-problems-remain-elevated-year-rcna15608).

Interventional cardiologists are cardiology subspecialists who are trained to place stents in clogged arteries to allow blood to flow properly and reduce risk of stroke or heart attack, as well as to repair holes in the heart or place special devices in the heart to help it function properly. While the COVID-19 pandemic may or may not be subsiding, one thing is for certain – there are and will be short- and long-term side effects. Granting a waiver to Dr. Ahmadjee will help Washoe county's population deal with these side effects.

Department of Health and Human Services Nevada Division of Public and Behavioral Health (DPBH) has their own Nevada Heart Disease and Stroke Prevention and Control Program. Some of the more important facts listed are as follows:

- 13,000 Nevadans were hospitalized for coronary heart disease and stroke (primary diagnosis) in 2012.5
- Heart disease and stroke account for nearly 1 out of 3 deaths in Nevada.



 Heart disease has been the leading cause of death in Nevada accounting for 4,999 (24.8%) of deaths followed by stroke at fifth place, accounting for 867 (4.3%) of deaths.

Dr. Ahmadjee completed his residency in internal medicine and then went on to complete two fellowships, one in cardiovascular medicine and another in interventional cardiology. Dr. Ahmadjee is an exceptionally bright clinician with over 1600 diagnostic heart catheterizations, several publications, research projects, and is board certified in Internal Medicine.

Generally, interventional cardiologists are required to successfully complete a total of six years of post-medical school training in internal medicine and a general cardiology fellowship, followed by two to three additional years of training in interventional cardiology, for a total of eight to nine years of postgraduate training — similar to the most advanced surgical subspecialties in medicine.

General cardiologists specialize in the diagnosis and care of patients with conditions such as hypertension, high cholesterol, and elevated risk of heart attack or stroke. They conduct and order many types of tests and procedures related to cardiovascular concerns — heart-rhythm disorders, for example — but they do not perform traditional "open" surgeries or endoscopic procedures. General cardiologists may follow up on subspecialist care and/or see patients long-term for cardiovascular concerns.

Interventional cardiology is the subspecialty of cardiology that uses specialized catheter-based techniques to diagnose and treat coronary artery disease, vascular disease, structural heart disease, and congenital heart defects. Interventional cardiologists use various diagnostic tools and imaging techniques to measure cardiovascular functions such as blood pressure and blood flow in major arteries throughout the body and within the different chambers of the heart. Interventional cardiologists do not perform traditional "open" heart surgeries. Interventional cardiologists are cardiology subspecialists who are trained to place stents in clogged arteries to allow blood to flow properly and reduce risk of stroke or heart attack, as well as to repair holes in the heart or place special devices in the heart to help it function properly.

Using cutting-edge technology and the newest techniques and complex advancements in this field of medicine — such as cardiac catheterization, transcatheter aortic valve replacement (TAVR), and mitral valve replacement and repairs — interventional cardiologists perform delicate life-saving and life-enhancing procedures to treat patients with heart disease, valve defects, or structural abnormalities. Interventional cardiologists usually are not an ongoing part of a patient's medical team, but rather a one-time or occasional care provider, when their specific expertise is required for a certain procedure.

Saint Mary's Medical Group currently employs nine Cardiologist and six APPs (Advanced Practice Providers). Two Cardiologist are resigning from full time employment the end of March 2022. We have a total of four vacancies, two Cardiologist and two APPs.

Saint Mary's Regional Medical Center has a total of fourteen Cardiologist and five APPs that have hospital privileges. Our Medical Staff department received a letter on behalf of the four Cardiologist from another hospital, stating that they will no longer be providing call coverage to our hospital effective April 1, 2022.

The closest hospital is approximately two miles from Saint Mary's Regional Medical Center and takes approximately 10 minutes.
