Renown Health along with the University of Nevada, Reno School of Medicine, respectfully requests your assistance in acting as an Interested Government Agency for recommendation of a flex spot waiver for the J-1 physician, Nikita Lopez, MD. We are seeking assistance of Nevada Division of Public and Behavioral Health as a state health agency in obtaining a waiver of the two-year foreign residency requirement for Dr. Nikita Lopez, who has agreed to practice in the position of Primary Care Physician-Internal Medicine in Washoe County for three years.

As the University of Nevada, Reno Office of Statewide Initiatives definitively reported in their February 2021 report (<a href="https://med.unr.edu/statewide/reports-and-publications/nevada-rural-and-frontier-health-data-book">https://med.unr.edu/statewide/reports-and-publications/nevada-rural-and-frontier-health-data-book</a>), the state of Nevada is broadly underserved with regard to healthcare services, and primary care is no exception.

There is an acute need for primary care physicians in Washoe County, in particular. In November 2021, the low-income population of Reno was confirmed by the Department of Health and Human Services as a Health Professional Shortage area (HPSA ID 1323717372), with an HPSA score of 14. This analysis estimated that Reno requires an additional 23.01 FTE of primary care providers to serve its low-income population. The problem is in part a function of the fact that many physicians in the area do not accept Medicaid. The University of Nevada, Reno is committed to the community we serve—particularly those living at or below the poverty line. We are one of the few primary care facilities in Reno that treat all patients regardless of their ability to pay, we accept Medicare, Medicaid, and NV Check-up.

UNR and our affiliate institution, Renown, have continuously recruited primary care physician positions to our medical practice, but it has been difficult to find a sufficient number of additional primary care physicians to meet the needs of our underserved population. For example, not a single applicant has applied for the three vacancies at Plumas Clinic which have been advertised nationwide for the past three months.

In addition to the issues associated with access to care in general, the shortage of physicians at our Plumas clinic has negatively impacted our ability to support Graduate Medical Education, a pipeline for future physicians serving Nevada. We have been unable to replace attending physicians that have moved on or retired, and this has created a negative spiral in which the physicians that remained find the workload increasingly untenable, and physicians potentially interested in a position potentially unwilling to join a practice in which they are likely to feel the full weight of the physician shortage.

#### **Description of residency training**

I, Nikita Lopez am currently a year 3 Internal Medicine resident receiving residency training at University of Nevada Reno School of Medicine, Internal Medicine Residency program which started on **July 1, 2019** and would be completed on June 30, 2022.

- Residency consisted of core rotations including inpatient ward rotations- day shifts and night shifts, ICU rotations, ambulatory medicine rotations and elective rotations.

#### 1. Inpatient ward rotations

During the inpatient rotations, I worked in a team of three consisting a senior resident and two interns who were supervised by an attending physician. This included admitting new patients and following on existing patients, triaging, advanced decision making, clinical reasoning, discussions, efficient discharge planning and more. Additionally, we would have didactic sessions varying from discussion of clinical cases, interactive academic sessions to attending lectures by guest lecturers and subspecialty lecturers. These rotations were distributed between Renown Regional Hospital (28 weeks of Wards, 2 weeks of Day float (which involves only admitting), 5 Weeks of night float), and VA Sierra Nevada Health care system, Reno (14 weeks of wards and 5 weeks of night float).

#### 2. The ambulatory rotations- Clinic

These rotations were done every 5<sup>th</sup> week at the University Health Clinic at Plumas Street **(32 weeks total)**, where again, we would have a combination of ambulatory clinical experience, involving ambulatory procedures, clinical reasoning, decision making etc and didactics.

#### 3. ICU rotations

These were again distributed between VA Sierra Nevada Health care system location at Reno (4 weeks) and Renown Regional at various ICUs including Roseview ICU, Cardiac ICU and Surgical/Medical ICU (9 weeks). We would be trained during these rotations by Intensivists and included admitting patients with them, performing procedures including central lines, arterial lines, intubation etc, training in difficult conversations with patients and family members and overall management of the critically ill.

Of note, we are also given the opportunity to do at least a **2-week rotation at Elko, Nevada**(03/22/2021-04/04/2021) where we are trained to work in resource limited settings and triage patients accordingly. I additionally requested for a week of elective in Pain management (05/02/2022-05/08/2022) in view of my interest in primary care.

#### 4. Elective rotations

I also had at least three weeks of elective rotations in various specialties during residency as listed below: -

#### **Pulmonology:**

- -Start and completion dates: **07/01/2019-07/06/2019**, **12/07/2020-12/13/2020**, along with upcoming pulmonology rotations from **05/30/2022 06/12/2022** and **06/20/2022-06/26/2022**.
- During this rotation, I had the opportunity to work with consultants at Renown hospital on various cases including acute vs chronic hypoxic respiratory failure, interstitial lung disease including IPF, Diffuse alveolar hemorrhage, complicated pneumonias etc. I was able to discuss imaging findings, diagnostic as well as management guidelines of the above and more, observe and attempt bronchoscopy, chest tube removal and management etc.

**Gastroenterology:** 

-Start and completion dates: 09/02/2019-09/15-2019, 12/14/2020-12/20/2020, 03/15/2021-

03/21/2021, 10/04/2021-10/10/2021

-During this rotation I had the opportunity to work with various consultants of Digestive Health

Associates, Reno on diagnosis and management of cases including upper and lower GI bleed, including

emergent cases of GI bleed involving emergent endoscopy and banding/cauterization, complicated

pancreatitis, management of hypertriglyceridemia induced pancreatitis, acute liver failure, cirrhosis of

various causes, elevated liver enzyme work up in general etc. Additionally, I was able to observe many

endoscopies, colonoscopies, banding, ERCPs and even minimally invasive management of complicated

pancreatic pseudocyst.

**Geriatrics:** 

-Start and completion dates: 10/28/2019-11/10/2019, 06/07/2021-06/20/2021

-Through this rotation, I was trained on comprehensive work up and management of the geriatric

population at the community living Centre in VA, Reno, along with the Geriatric fellows. Here I was able

to closely interact with physical therapists, occupational therapists, wound team to learn about various

aspects of rehab and wound care. Additionally, I was able to interact with the pharmacists there who

gave us an insight into inpatient vs outpatient management of various medications for geriatric

population. There were numerous didactic sessions focusing on the above.

Nephrology:

-Start and completion dates: 07/20/2020-08/09/2020

-I had the opportunity to work closely with consultants from Sierra Nevada Nephrology group and was

able to work up, discuss diagnosis and management guidelines for dialysis patients, acute renal failure,

complications in transplant patients, acute kidney injury work up in general, acid base disorders, etc.

Additionally, I was introduced to peritoneal dialysis, deciding on who is a good dialysis or transplant

candidate or candidates for renal biopsy etc.

**Emergency Medicine:** 

-Start and completion dates: 09/21/2020-09/27/2020, 11/09/2020-11/22/2020, 04/25/2022-

05/01/2022.

-Through this rotation, I was able to work with ER physicians at the Renown and VA ER during their

assigned shift and with their help experienced how to handle trauma, code strokes, code Blue etc.

Additionally, I was also able to gain experience in making appropriate decisions on triaging, imaging,

management and disposition of ER patient. Additionally, gained experience in suture repair of various

types of lacerations.

Neurology:

-During this rotation I was able to work with various Neurologists who trained me in localization of CVAs

from patients' presentation and correlating the same with imaging, on how to run a code Stroke and

make prompt decisions regarding imaging and TPA vs thrombectomy, work up of encephalopathy including that associated with PRESS, ICU neuropathy, management of seizures and identifying pseudo seizures etc.

-I was able to experience both inpatient and outpatient aspects of this specialty. I received training here on work up and management of cases ranging from anemia, pancytopenia, ITP, DVTs, Hypercoagulable states to various oncological cases. We discussed during this rotation regarding updated guidelines for management of various cancers and additionally rounded on patients in the infusion centers.

#### Cardiology:

-I was able to work closely with cardiologists at Renown both on call and non-call days. Trained on EKGs, Stress test, Echocardiograms, management of ACS, valvular abnormalities, Heart failure from various causes etc. Additionally, was also able to discuss vascular imaging for DVTs, outpatient management of high ASCVD patients etc.

#### **Endocrinology**
