Community Health Workers:

Expand Medicaid reimbursement of CHWs under the supervision of behavioral health clinicians.

Behavioral Health Workforce 1: Address shortage by reviewing the expansion of behavioral health training programs to get investment to increase graduates.

Behavioral Health Workforce 2: Support the creation of a common definition for clinical supervision that would align with accreditation standards of the combined educating bodies and the licensing boards

Standards/Policies for Children's System of Care: Establish in statute the authority for DCFS to establish standards for providers, allowing the development of a baseline/policies and monitor through certification

Law Enforcement Diversion and Deflection: Propose specific policy modernizing language in NRS 458.175 to modernize existing statute around civil protective custody and come into line with existing standards of care

Supportive and other housing for very low and extremely low-income Nevadans: Increase RPTT directed to AFAH to .25 per \$500 sales value with the increased amount directed to a new ELI/VLI/SH Deep Subsidy Account

Collaborative Care Model for SUD: Legislation to support the CoCM through turning on the existing CPT codes to cover the Collaborative Care Model; and supporting state implementation and system transformation to improve overall health outcomes, resolve health inequities and save costs.
