COMMUNITY ELIGIBILITY PROVISION (CEP)

Community Eligibility Provision is an alternative to collecting household applications for free and reduced price meals in high poverty local educational agencies (LEA) and schools. Eligible LEAs/schools agree to serve all students free lunches and breakfasts during four successive school years. CEP will be available for all districts beginning the 2014-2015 school year.

LEAs may elect the CEP for the entire district, individual schools or a group of schools. To be eligible, the LEA, individual school or group of schools must have an identified student direct certification percentage of at least 40%. Identified students are those certified for free meals **not** through individual household applications. Students must be directly certified through SNAP, TANF, FDPIR, foster, migrant and homeless.

LEAs will be reimbursed by multiplying the identified student percentage by a factor of 1.6 which provides the percentage of total meals served reimbursed at the Federal free rate. The remaining percentage of total meals is reimbursed at the Federal paid rate. Any cost in excess of the total Federal reimbursement must be covered through non-Federal sources.

Annually by April 1, LEAs and schools must:

- Run direct certification matches to obtain current counts of SNAP, TANP, and FDPIR participants; and
- Match homeless, migrant youth and foster children

These constitute the identified student percentage. Each year of the 4-year cycle, LEAs or schools may use the identified student percentage from the first year, or the updated identified student percentage, whichever is higher.

Implementation Issues

- Food Service no longer collects applications or has individual free and reduced student data for schools participating in CEP
- Potential redistribution of school-level Title I funds
- Need for alternative data for State and local funding formulas
- Need for individual free and reduced price data for E-rate discount level determinations
- Need for individual data for student testing
- Child nutrition at State and local level can't collect income data or incur cost for collecting income data for schools participating in CEP
- Districts or States will have to develop income data application

Projected Benefits

- Increase in breakfast and lunch participation
- Increase financial viability of school food service programs
- Decreases administrative burden for school food service programs

The Nevada Department of Agriculture published a list of district and schools who are eligible or near eligible to participate in CEP. Districts have until August 31, 2014 to declare which schools will participate in CEP for the 2014-2015 school year. Below is the list of districts and schools who are eligible or near eligible to participate in CEP. Clark and Nye County Schools Districts are the only districts who have identified schools that will be participating in CEP.
